#### ELIGIBILITY

- Candidates with a Post-Graduation Degree with a minimum of 60% aggregate will be considered
- Candidates are required to devote their full-time towards Ph.D.
- Shortlisted candidates will have to come for test and /or interview
- Preference will be given to candidates working in ongoing sponsored projects in the Institute, and the UGC-NET-JRF qualified candidates.

#### FINANCIAL SUPPORT

Those Full-time PhD students admitted into the PhD programme are eligible to be considered for fellowship of ₹28,000 or ₹31,000 per month as per intake qualifications. Consideration for fellowship will be as per Institute norms, details of which are available in the PhD brochure on the admission website. It will be obligatory on the part of every admitted full time student to undertake 8 to 10 hours (per week) of work as assigned to her/him by the Institute.
